

validity on the ground that it is not within the powers of the Act, or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act, or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

Contraction of the Flintshire Foot-and-Mouth Disease Infected Area.

Substitutes the following Area for the Infected Area described in the Schedule to the

Foot-and-Mouth Disease (Infected Areas)
Order of 1932 (No. 16):—

An Area comprising:—

In the County of Flint.

The borough of Flint.

The petty sessional divisions of Mold, Northop and Hope and the parishes of Buckley Hawarden, and Hawarden.

In the County of Denbigh.

The parishes of Llanferres and Llanarmon.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction of a sum of One thousand pounds heretofore held by us for the spiritual benefit of the Parish of Scarborough, in the County and Diocese of York, and now specifically appropriated for the endowment of the New Parish and Vicarage (hereinafter called the Benefice) of Saint Columba, Scarborough, which has recently been formed out of the said Parish of Scarborough, Do Hereby in pursuance of the Act of the twenty-ninth and thirtieth years of Her late Majesty Queen Victoria, Chapter one hundred and eleven, section five, Grant out of the Common Fund under our control to the Incumbent for the time being of the said Benefice of Saint Columba, Scarborough, and to his successors Incumbents of the same Benefice, all and singular, one yearly sum or stipend of forty-five pounds, such yearly sum or stipend to be calculated from the twenty-second day of July in the year one thousand nine hundred and thirty-two and to be payable in four equal portions on the first day of February, the first day of May, the first day of August and the first day of November in each and every year: Provided always that the yearly sum or stipend hereby granted shall be and shall be taken to be in lieu of and in full substitution for the yearly sum or stipend of like amount heretofore payable by us towards the stipend of the Curate serving the Church of Saint Columba, in the said Parish of Scarborough, under the authority of an Instrument which was sealed by us on the sixteenth day of October in the year one thousand nine hundred and thirty and was published in the London Gazette on the twenty-eighth day of the same month. Provided also that if at any time lands, tithes or other hereditaments sufficient in our opinion to produce the said yearly sum or stipend of forty-five pounds or any part thereof, shall be annexed by us to the said Benefice in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of the yearly sum or stipend or of such part thereof as the case may be, shall thereupon and thereafter cease and determine.
