MINISTRY OF TRANSPORT.

ROAD TRAFFIC ACT, 1930.

Notice is hereby given that the Minister of Transport, in exercise of the powers conferred upon him by the Road Traffic Act, 1930, has made the Motor Vehicles (Authorisation of Special Types) Order (No. 5), 1932, to come into operation on the 1st day of November, 1932.

The Order authorises the use on roads of certain vehicles (more particularly specified in the Order) which are the property of or for the time being under the control of the Admiralty, Secretary of State for War or the President of the Air Council, notwithstanding that such vehicles do not in all respects comply with the requirements of the Motor Vehicles (Construction and Use) Regulations, 1931.
