ELEVENTH SCHEDULE.

1932 REVIEW OF THE OPERATION OF THE RAILWAY FREIGHT REBATES SCHEME AND APPLICATION IN RESPECT OF ADMINISTRATIVE EXPENSES.

NOTICE is hereby given that the Railway Rates Tribunal will sit at 10.30 a.m. on Wednesday, the 16th November, 1932, in Court "A", Judges' Quadrangle, Royal Courts of Justice, London, W.C.2, to review the operation of the Railway Freight Rebates Scheme for the year ending 30th September, 1932, pursuant to the provisions of Part I of the Eleventh Schedule to the Local Government Act, 1929.

Notice is also given that the Railway Companies to which the said Scheme applies have filed with the Tribunal an Application (1932 No. 15) pursuant to the provisions of sub-paragraph 1 (a) of paragraph 5 of the said Part I of the Eleventh Schedule that in respect of the year 1st October, 1932, to 30th September, 1933, the sum to be paid out of the general monies of
