

CHARLOTTE CAROLINE COOPER, Deceased.

**I**N PURSUANT to an Order of the Chancery Division of the High Court of Justice in England, dated 8th June, 1931, and made in an action in the matter of the estate of Charlotte Caroline Cooper, Spinster, deceased (late of 42, Crescent Gardens, and formerly of 8, Pierrepont Street, Bath, in the county of Somerset), *The Public Trustee v. Dwelly*, 1931. C. 1,720, whereby the following inquiry was directed, viz.:—

"An inquiry what person or persons upon the death of the said Charlotte Caroline Cooper on the 14th. of March, 1929, became entitled to any property of hers as to which she died intestate and for what estates and interests and in what shares and proportions and whether any such persons are since dead and if they died entitled to any vested share or interest who are their legal personal representatives."

The said Susannah Mary Simmons was born on 5th January, 1847, at 25, St. James's Parade, St. James's, Bath, and is believed to have died in infancy.

The said Edith Cicely Hart was born on 8th November, 1899, at 7, Green Street, Walcot, Bath. She was educated at the New Orphan Houses, Ashley Down, Bristol, and was formerly in the employ of Mrs. Rumsey, of 7, Manor Park, Redland, Bristol, as a General Servant.

The said James Hart was born on 22nd March, 1873, at 1, Harley Street, Lansdowne, Bath, and in the year 1881 was an inmate of Frome Road House Poor Law Institution for the Union of the city of Bath and thence was sent to Canada. He was last heard of as a young man in Canada where he worked in a Post Office there.
