REGULATIONS MADE BY THE TREASURY FOR THE DRAWING OF £3 PER CENT. TREASURY BONDS.

The Lords Commissioners of His Majesty's Treasury, in pursuance of the power reserved to them by the Prospectus dated the twenty-ninth day of April, nineteen hundred and

thirty-two, to make Regulations with respect to drawings of the three per cent. Treasury Bonds issued in accordance with the terms of the said Prospectus hereby make the following Regulations.

to them by the Prospectus dated the twenty- 1. The Bonds to be issued will be of the ninth day of April, nineteen hundred and following numbers and denominations, viz.:—

26,400 Bonds of £50 each 1,320,000 A1 to A26,400 ... 48,400 Bonds of B1 to B48,400 £100 each 4,840,000 C1 to C13,200 13,200 Bonds of £200 each = 2,640,000 ... D1 to D17,600 17,600 Bonds of £500 each 8,800,000 • • • E1 to E92,400 92,400 Bonds of £1,000 each = 92,400,000£110,000,000 198,000

For the purpose of the annual drawings Bonds of the smaller denominations will be grouped as follows:—

Bonds of £50 in groups of 20. Bonds of £100 in groups of 10. Bonds of £200 in groups of 5. Bonds of £500 in groups of 2. £1,000 Bonds will not be grouped.

- 2. The Bank of England will prepare 110,000 card discs printed with the cypher letters and numbers of the various Bonds or groups of Bonds, the discs for the several denominations being distinguished by the use of different colours.
- 3. On a day or days to be fixed by the Treasury, not later than the 1st December, 1932, the discs for each denomination shall be placed in a separate receptacle at the Bank of England in the presence of the Permanent Secretary to the Treasury, or a person nominated by him, of the Comptroller General of the National Debt Office, or a person nominated by him, and of the Governor or Deputy Governor of the Bank of England, or, failing both, a person nominated by the Governor or Deputy Governor.
- 4. In the presence of the same persons the receptacles containing the discs shall be placed in a tin box or boxes secured by three locks of which the respective keys shall be held by the Permanent Secretary to the Treasury, the Comptroller General of the National Debt Office, and the Governor of the Bank. The box or boxes shall be deposited at the Bank.
- 5. On a day or days prior to the 15th December in each year from 1932 onwards until all the Bonds have been paid off, and of which at least ten days notice shall be given in the London Gazette, the box or boxes shall be

opened in the presence of the Permanent Secretary to the Treasury, or a person nominated by him, of the Comptroller General of the National Debt Office, or a person nominated by him, and of the Governor or Deputy Governor of the Bank of England, or failing both, a person nominated by the Governor or Deputy Governor, and discs shall be drawn without selection to such aggregate number as can be redeemed by means of the moneys provided on each occasion for the redemption of Bonds (not being less than £11,000,000 or an amount equal to the balance of the Bonds outstanding if less than that figure) and so that on each occasion the same proportion of discs to the total number of discs in each receptacle shall as nearly as may be possible be drawn for each denomination.

6. A list of the numbers in each denomination so drawn shall be signed by the aforementioned persons and delivered to the Lords Commissioners of His Majesty's Treasury who shall cause the list to be published in the London Gazette not later than the 15th December with an intimation that the corresponding £3 per cent. Treasury Bonds will be paid off at par on the 15th April following, from which date interest thereon will cease, and that the Bonds, when presented for payment, must be accompanied by all coupons bearing date subsequent to the said date for repayment.
