WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her late Majesty, Queen Victoria, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, Grant out of our Common Fund to the Incumbent for the time being of each of the Benefices whereof the names and the names of the Counties and Dioceses wherein the same are respectively situate are stated in the first three columns of the Schedule hereto, one yearly sum or stipend of sixty pounds, such year sum or stipend to be payable for the period commencing on the date stated in the fourth column of the said Schedule opposite to the name of the Benefice, and terminating on the first day of November in the year one thousand nine hundred and thirty-four unless at any time before the expiration of the said period the grant of such stipend shall have been cancelled or withdrawn by a resolution of us, the said Ecclesiastical Commissioners, and to be payable so long as the same shall continue in four equal portions on the first day of February, the first day of May, the first day of August and the first day of November in each year: Provided always that such yearly sum or stipend or any quarterly portion thereof shall (L.S.)

be payable only upon the production to uson or after each of the said last mentioned quarterly days of payment of a certificate (in such form as may be required by us) under the hand of the Bishop of the Diocese in which the Benefice is situate certifying that, during the quarter then ended, there has been employed within the Parish of the Benefice and duly licensed by such Bishop such number of Assistant Curates as is stated in the fifth column of the said Schedule and that the last in order of such number of Assistant Curates has been in receipt of a stipend after a rate of not less than one hundred and twenty pounds per annum: Provided also that such yearly sum or stipend is granted upon and is payable only subject to satisfaction of the further conditions (if any) stated with reference thereto at the foot of the said Schedule: Provided lastly that this Instrument which is intended to be executed in several parts (one part for each Diocese concerned) shall operate only as a single grant in favour of each of the Benefices mentioned in the said Schedule.

In witness whereof we have hereunto set our Common Seal this thirteenth day of October in the year one thousand nine hundred and thirty-two.

URBAN DISTRICT OF OTLEY.

PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

B^Y an Order dated the twelfth day of October, 1932, the Minister of Health has declared that, on and after the seventh day of November, 1932, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the Urban District of Otley, namely :-

Part II (Streets and Buildings) other than sections 21, 24, 25, 31 and 32.

Part III (Sanitary Provisions) other than sections 34, 48, 50 and 51.

Part IV (Infectious Diseases) other than sections 61, 62, 65 and 68.

Section 95 in part X (miscellaneous provisions).

The above provisions are declared to be in force subject as regards sections 23, 27, 30, 35 and 38 to the conditions specified in the Order.

The Minister of Health has also repealed, as from the seventh day of November, 1932, the undermentioned provisions of the Otley Improvement Act, 1905, namely:-

Sections 4, 5, 6, 8, 14, 15, 19, 20, 21, 22, 23, 29, 30, 38, 45, 46, 48, 51, 55, 57, 60, 64, 65, 71, 73, 74, 75, 76, 77, 79, 80, 82, 83, 86, 87, 89 and 113.
