late Majesty, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 13th day of October, 1932, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District for spiritual purposes to be taken partly out of the New Parish (sometime Consolidated Chapelry) of Saint Luke, New Catton, partly out of the Parish of Hellesdon, and partly out of the Parish of Heigham, all in the County of Norfolk and in the Diocese of Norwich:

"Whereas we are satisfied that the said New Parish of Saint Luke, New Catton, the said Parish of Hellesdon and the said Parish of Heigham are Cures wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it has been made to appear to us that it would promote the interests of religion that the particular portions of the said New Parish of Saint Luke, New Catton, of the said Parish of Hellesdon, and of the said Parish of Heigham which are hereinafter mentioned and described, should be constituted a separate District in the manner which is hereinafter set forth:

"And whereas there is not at present within the limits of the said proposed separate District any consecrated Church or Chapel in use for the purposes of Divine Worship:

"And whereas we have agreed to make and pay out of the Common Fund created by the firstly herein mentioned Act a grant of £200 per annum to the Minister of the said proposed separate District so soon as a Minister shall have been duly licensed in accordance with the provisions of the secondly herein mentioned Act and to his successors:

"And whereas the said grant of the said yearly sum of £200 will, after the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme, be made and secured by an Instrument to be executed by us, the said Ecclesiastical Commissioners, under our Common Seal in accordance with the provisions of the Act of the 29th and 30th years of Her said late Majesty, Chapter 111:

"Now, therefore, with the consent of the Right Reverend Bertram, Bishop of Norwich (in testimony whereof he has signed and sealed this Scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that all those portions of the said New Parish of Saint Luke, New Catton, of the said Parish of Hellesdon and of the said Parish of Heigham, which are described in the Schedule hereunder written, all which portions together with the boundaries thereof are delineated and set forth on the map or plan hereunto annexed, shall, upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme as aforesaid, become and be

constituted a separate District for spiritual purposes and that the same shall be named 'The District of Saint Catherine, Mile Cross'.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Catherine, Mile Cross, comprising:—

"I. All that portion of the New Parish (sometime Consolidated Chapelry) of Saint Luke, New Catton, in the County of Norfolk and in the Diocese of Norwich, which is bounded upon the north west and upon the south west by the Parish of Hellesdon, in the said County and Diocese, and upon the remaining sides, that is to say, upon the south east and upon the north east, by an imaginary line commencing upon the boundary which divides the said Parish of Hellesdon from the said New Parish of Saint Luke, New Catton, at a point in the middle of Drayton Road opposite to the wall or fence forming the boundary between the houses and premises situate on the western side of Junction Road and the allotment gardens in the close numbered 1242 upon the Ordnance Survey Map of the Parliamentary Borough of Norwich, published in the year 1907 on the scale of 25 inches to a mile and also upon the map or plan annexed to this Scheme, and extending thence north eastward to and along the wall or fence forming the eastern boundary of the said close for a distance of 17½ chains or thereabouts to the point where it reaches the south western side of Aylsham Road and extending thence first north eastward to and then north westward along the middle of Aylsham Road for a distance of 60 chains or thereabouts to its junction with Boundary Road upon the boundary which divides the said New Parish of Saint Luke, New Catton, from the said Parish of Hellesdon.

"II. Also all that contiguous portion of the said Parish of Hellesdon which is bounded upon the south by the Parish of Heigham, in the said County and Diocese, upon the east and upon the north east by the said New Parish of Saint Luke, New Catton, and upon the remaining side, that is to say, upon the west, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Luke, New Catton, from the said Parish of Hellesdon, at a point in the middle of Drayton Road near its junction with Hellesdon Hall Road and opposite to the northern end of the fence forming the north western boundary of the houses and premises known as Slough Bottom Cottages and extending thence south westward to and along such fence for a distance of 1 chain or thereabouts to the point where it meets the fence forming the south western boundary of the same premises, and extending thence south eastward along the last mentioned fence for a distance of 8 chains or thereabouts to its south eastern end and extending thence southward to and along the fence forming the western boundary of the Drayton Housing Estate for a distance of 271 chains or thereabouts to the
