UNIVERSITY OF OXFORD.

STATUTE APPROVED BY CONGREGATION ON TUESDAY, 1ST NOVEMBER, 1932.

Whereas it is expedient to amend Sect. 1. § 1 of Title VII of the Statutes of the University of Oxford so far as it relates to the qualifications for election to a Craven Fellowship: NOW THE SAID UNIVERSITY, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge

Act, 1923, and of all other powers enabling it, ENACTS, subject to the approval of His Majesty in Council, AS FOLLOWS.

In *Statt. Tit. VII. Sect. 1. § 1, cl. 2 (Statuta, ed. 1932, p. 164, l. 15)*, delete the words "kept three years' full residence and" and substitute the words "entered upon the eighth Term but".

UNIVERSITY OF OXFORD.

STATUTE APPROVED BY CONGREGATION ON TUESDAY, 1ST NOVEMBER, 1932.

Whereas it is expedient to amend Title V of the Statutes of the University of Oxford, in order to provide that the holders of certain offices shall be official members of the Board of the Faculty of Medicine: NOW THE SAID UNIVERSITY, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, ENACTS, subject to the approval of His Majesty in Council, AS FOLLOWS.

In *Statt. Tit. V. Sect. VIII. § 3 (Statuta, ed. 1932, p. 152)*, cl. 3 shall be struck out and the following substituted:—

"3. Unless the University shall by Statute determine otherwise, the six official members shall be the following:—

Dr. Lee's Professor of Human Anatomy.
 The Waynflete Professor of Physiology.
 The Professor of Pathology.
 The Professor of Pharmacology.
 The Whitley Professor of Biochemistry.
 The Margaret Ogilvie's Reader in Ophthalmology."
