The following Statute made by the Governing Body of Christ Church, in the University of Oxford, on the 15th day of December, 1932, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1923."

CHRIST CHURCH, OXFORD.

AMENDMENTS to the existing Statutes of Christ Church in the University of Oxford, duly made, under the provisions of the Universities of Oxford and Cambridge Act, 1923, at a Meeting of the Governing Body specially summoned for the purpose on the 15th June, 1932, and passed at that Meeting by the votes of two-thirds of the number of persons present and voting, and submitted to His Majesty The King in Council.

X.—TUITION FUND.

In Clause 1, line 1, for the word "Lecturers" substitute:—

for payments made for teaching to Research Students and Lecturers,

XVII.—THE STUDENTS.

Clause 2. Delete the whole clause, and the amendment of 20th January, 1930, and substitute:—

2. The Governing Body may, if and when the funds at its disposal permit, elect to

Research Studentships persons who have done or are doing valuable work in letters or science, or have attained special distinction in some branch of knowledge, on condition that they shall undertake to perform some definite literary or scientific work in the House or in the University or (with the permission of the House) elsewhere, which work shall be specified in the Resolution by which they are elected. The Office of Librarian may, subject to his consent given in writing, be assigned to a Research Student. Such Students shall be elected in the first instance for a period of five years, and may be re-elected for further periods of five years, but so that a Research Student shall not hold his studentship after the age of 65, unless the Governing Body shall resolve, by the votes of not less than two-thirds of the number of persons present and voting, to extend the tenure of his Studentship for a further period of five years. The salaries of such Students shall be determined by the Governing Body. A limited amount of teaching may be undertaken by a Research Student, subject to his consent and to that of the Governing Body. Any Student who fails to comply bona fide with the conditions of his election shall be removed from his Studentship.

XX.—LECTURERS OTHER THAN OFFICIAL STUDENTS.

Add the two following Clauses:—

2. The Governing Body may appoint as Lecturers persons who are well qualified to

engage in original research, subject to the condition that they shall undertake to perform some definite literary or scientific work in the House or in the University or (with the permission of the House) elsewhere, and shall submit an annual report of their work to the Governing Body. The salaries of such Lecturers shall be determined by the Governing Body and payable from Corporate Revenues. Such Lecturers shall be appointed for a period of two years, and may be re-appointed for further periods up to a maximum total of five years. A limited amount of teaching may be undertaken by such Lecturers, subject to their consent and to that of the Governing Body.

3. If the funds at the disposal of the Governing Body permit, at least one Lecturership shall be offered in each year.

XXIII.—COLLEGE EXHIBITIONS.

Delete the whole of the 2nd paragraph, beginning "No person . . .".

Delete the whole of the 3rd paragraph, beginning "There shall be . . .", and substitute:—

There shall be an election to not more than four Exhibitions in each year. Each Exhibitor shall be entitled to dinner in Hall and be excused the payment of the usual Entrance Fee. He shall also be entitled to apply after his election for the grant of pecuniary emoluments not exceeding £80 a year; and the Governing Body may grant him that or any less sum, provided that after enquiry it is satisfied that he is in need of such assistance.

XXX.—SENIOR SCHOLARSHIPS.

Clause 1. Delete the whole of the last sentence beginning in line 7 "There shall be . . .".

Clause 2. Delete the whole Clause.

Clause 3. Delete the following:—

The words "of class (b)" in line 1 and the words "of this class" in lines 6, 11, 17 and 18.

TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 8th January, 1933, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919, to the amount of £45,000,000.

2. The Bills will be in amounts of £5,000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday, the 9th January, 1933, to Saturday,

the 14th January, 1933, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.
