PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR MALE AND FEMALE WORKERS.

In accordance with Regulations made by the Minister of Labour under section 18 of the Trade Boards Act, 1909, and dated 21st April, 1927, the Rope, Twine and Net Trade Board (Great Britain) HEREBY GIVE NOTICE that they PROPOSE TO VARY all the minimum rates of wages for male and female workers set out in the Notice R.(48), issued by the Trade Board and dated 13th August, 1930.

Particulars of the proposed variations may be obtained on application to the Secretary of the Trade Board.

In accordance with Section 3 (5) of the Trade Boards Act, 1918, the Trade Board WILL CONSIDER ANY OBJECTIONS to the above Proposal to Vary which may be lodged with them within two months from the 24th January, 1933. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address),

and should be sent to the Secretary, Rope, Twine and Net Trade Board (Great Britain), 1, Whitehall Gardens, London, S.W.1. It is desirable that Objections should state precisely and, so far as possible with reasons, what is objected to.
