MINISTRY OF TRANSPORT.

IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Transport, after the expiration of at least forty days from this date, in pursuance of the powers conferred upon him by Section 7 of the aforesaid London Traffic Act to make Regulations amending the London Traffic (Restricted Streets) Regulations.

And notice is hereby further given that, on account of urgency, the Minister has under Section 2 of the Rules Publication Act, 1893, made the London Traffic (Restricted Streets) Amendment (Route No. 156B) Provisional Regulations, 1933, to come into operation forthwith as Provisional Regulations to continue in force until Regulations have been made in accordance with the provisions of Section 1 of that Act.

These Regulations provide for the operation of certain additional early morning omnibus journeys on Route No. 156B (Morden Station and St. Helier Avenue, Mydleton Road).

AGRICULTURAL MARKETING ACT, 1931.

NOTICE OF SUBMISSION OF BACON MARKETING SCHEME.

Any objections and representations with respect to the scheme should be made to the Minister of Agriculture and Fisheries and the Secretary of State for Scotland, and addressed to the Secretary, Ministry of Agriculture and Fisheries, 10, Whitehall Place, London, S.W.1, the Under-Secretary of State for Scotland, Scottish Office, Whitehall, or the Secretary, Department of Agriculture for Scotland, York Buildings, Queen Street, Edinburgh, so as to reach them not later than 7th March, 1933; objections received after that date will not be considered. Every objection must be made in writing and must state the grounds of objection and the specific modifications required.

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1933 (No. 22).

SUBJECT.

Revokes Foot-and-Mouth Disease (Infected Areas) Orders of 1933 (Nos. 6, 7 and 8) and declares the following to be Foot-and-Mouth Disease Infected Areas for the purposes of the
