

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day-shifts, of women of 18 and young persons of 16 years of age and over in wool carding and spinning in the Spinning Department at the works of Messrs. Houstons Limited, Robins Lane, Frome, Somersetshire,

subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks and that suitable accommodation for clothing put off during working hours, messroom accommodation at or near the works and washing facilities shall be provided.

Two Hackney Carriages:

On North side of roadway, commencing at a point fifty-six feet East of gates leading to platform, extending Eastward, by kerb, as far as necessary for two cabs.

Front of cabs toward the West.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriage-way, or upon any place where foot passengers usually cross the carriage-way.
