# TENDERS FOR TREASURY BILLS AND £2 10s. PER CENT. CONVERSION LOAN, 1944-1949.

- 1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 5th May, 1933, at 1 o'clock, for
  - (a) Treasury Bills to be issued under the Treasury Bills Act, 1877; the National Debt Act, 1889; and the War Loan Acts, 1914-1919; and
  - (b) £2 10s. per cent. Conversion Loan, 1944-1949.
- 2. The maximum amount of Treasury Bills and £2 10s. per cent. Conversion Loan to be allotted on that date will be £50,000,000. The amount of £2 10s. per cent. Conversion Loan allotted will not exceed £10,000,000, but subject to that limit the total amount allotted will be divided between Bills and Conversion Loan in such proportions as Their Lordships may determine.

### TREASURY BILLS.

- 3. The Bills will be in amounts of £5,000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday, the 8th May, 1933, to Saturday, the 13th May, 1933, inclusive, and will be payable at three months after date.
