TOWN AND COUNTRY PLANNING ACT, 1932.

PREPARATION OF PLANNING SCHEMES.

Notice is hereby given in pursuance of the Town and Country Planning (General Transitional) Order, 1933 (S.R. & O., 1933, No. 239) that resolutions deciding to prepare Town Planning Schemes were passed and took effect, or authority to prepare Town Planning Schemes was granted, before the 1st day of April, 1933 (the date on which the Town and Country Planning Act, 1932, came into operation) for areas situate in the boroughs and districts specified in the first column of the Schedule hereto, and that schemes in respect of those areas are being prepared by the authorities specified in the second column of the said Schedule:

And notice is hereby further given that in each case a map defining the area to which the resolution or authority applies has been deposited at the place or places specified in the

third column of the said Schedule, and will be open for inspection by all persons interested without charge between the hours mentioned in the fourth column of the Schedule and that any person who is or claims to be an owner of property in the area, and any association representing owners of property within the boroughs and districts named in the first column of the said Schedule, and any local association representing business or industry may by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the appropriate local authority or joint committee specified in the second column of the said Schedule to register without charge his or their name and address for the service of subsequent notices relating to the scheme.
