The following Statute made by the Governing Body of Merton College, in the University of Oxford, on the 29th day of May, 1933, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1923."

The Governing Body of Merton College beg respectfully to submit to His Majesty The King in Council the following amendments to the College Statute III, Sections 8 and 10, which were passed by the votes of not less than two-thirds of the number of persons present and voting at a Stated General Meeting of the College specially summoned for the purpose on Monday, March 13, 1933. Notice of these amendments has been given to the Hebdomadial Council, as required by the Universities of Oxford and Cambridge Act, 1923.

## NEW STATUTE AMENDING STATUTE III.

(i.) In 8 (a) delete the last sentence and substitute the following sentence—

"He shall when required by the Governing Body submit a report to the College on the research work on which he is engaged."

(ii.) After 8 (a) insert a new sub-section—namely,

"(aa) A Junior Research Fellow may with the leave of the Governing Body undertake educational work in the University or a College. The Governing Body may from time to time make regulations for the purpose of carrying this sub-section into effect."

(iii.) In 8 (d) after the words "Bachelor of Arts" insert the words "or any other degree."

(iv.) At the beginning of 8(f) insert the words—

"Notice of every election to a Junior Research Fellowship and of the conditions of election shall be given by the Warden in such manner as he may deem best adapted to secure publicity at least thirty days before the day of election."

(v.) In 10 (c) substitute £300 for £250.

## TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 9th June, 1933, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919, to the amount of £50,000,000.

2. The Bills will be in amounts of £5,000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday, the 12th June, 1933, to Saturday, the 17th June, 1933, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday, 12 o'clock) on the day on which the relative Bills are to be dated.
