

Section 6 of the London Traffic Act, 1924, on weekdays upon any approved route shown in Column 1 of the Second Schedule hereto from using, on that day, after 10 a.m. for the purpose of plying for hire in any of the streets or parts thereof declared to be "restricted streets" by any Order made by the Minister of Transport under the aforesaid Section 7 of the London Traffic Act, 1924, and forming part of any of the approved routes or parts thereof shown in Column 2 of the said Second Schedule, such number of omnibuses as is shown opposite to each

such route or part thereof respectively in Column 3 of the said Second Schedule in excess of the number of omnibuses which he may use in those streets or parts thereof under the said Regulations;

provided that nothing herein contained shall be deemed to affect or derogate from the powers of the Commissioner of Police of the Metropolis under the provisions of Section 52 of the Metropolitan Police Act, 1839, to give directions to constables for keeping order and for preventing any obstruction of the thoroughfares.

LONDON TRAFFIC ACT, 1924.

SECTION 7.

Notice is hereby given that the Minister of Transport by virtue and in exercise of the powers given to him by Section 7 of the London Traffic Act, 1924, and the Regulations from time to time made by him thereunder, after consulting the London and Home Counties Traffic Advisory Committee, has relaxed the restrictions and limitations imposed by the said Regulations upon the occasion of the Fete to be held at Dr. Barnardo's Home, Barking, on Saturday, the 24th day of

June, 1933, so that nothing in the said Regulations shall:—

(a) prevent the London General Omnibus Company Limited from using on that day after 11 a.m. for the purpose of plying for hire in any of the streets or parts thereof declared to be "restricted streets" by any Order made by the Minister of Transport under the aforesaid Section 7 of the London Traffic Act, 1924, and forming part of the approved route numbered 28E two omnibuses in excess of the number of omnibuses which they may so use in those streets or parts thereof under the said Regulations:
