Captain (E), the qualification prescribed by Order in Council dated 17th May, 1867, namely, long and meritorious service, being cancelled when the provisions of this Order become operative."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of

what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.
