And whereas the requirements of Section 8 of the University of London Act, 1926, have

been duly observed:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to re-appoint The Right Honourable Lord Macmillan and Sir Edwin Cooper Perry, to be members of the Court of the said University of London for a term of five years; from the 1st October, 1933.

WHEREAS by Section 30 of the Municipal Corporations Act, 1882, as amended by the Municipal Corporations Act, 1893, and extended by the Borough Councillors (Alteration of Number) Act, 1925, it is (amongst other things) enacted that if a majority of the whole Council of a Borough agree to petition, and the Council thereupon petition, The King for an alteration of the number of Councillors of a Borough, it shall be lawful for His Majesty from time to time by Order in Council to fix the number of Councillors to be allotted to such Borough:

And whereas by the Birmingham Extension Act, 1927, a new Ward of the City of Birmingham to be called "the Perry Barr Ward" was

constituted:

And whereas it was provided by the said Act, and subject to certain conditions thereby imposed, that if the number of persons rated in the Perry Barr Ward or the aggregate rating of the Ward increased so as to justify an increase of the number of Councillors of the Ward it should be lawful for the Council to petition The King for an alteration of the number of the Councillors of the Ward and for the purposes of any such Petition and the proceedings thereon the provisions of Section 30 of the Municipal Corporations Act, 1882, as amended by the Municipal Corporations Act, 1893, and extended by the Borough Councillors (Alteration of Number) Act, 1925, should apply with the necessary modifications as in the case of a Petition presented by the Council of a Borough not divided into Wards praying only for an alteration of the number of Councillors of the Borough:

And whereas a majority of the whole Council of the City of Birmingham on the 10th day of

January, 1933, agreed to petition, and the said Council thereupon petitioned His Majesty for an alteration of the number of Councillors of the Perry Barr Ward of the said City:

And whereas His Majesty was pleased by His Order in Council of the 25th day of May, 1933, to refer the said Petition to a Committee of the Lords of His Majesty's Most Honourable Privy Council to consider the same on the 26th day of June, 1933, and report their opinion thereon to His Majesty in Council:

And whereas Notice of the said Petition and of the time when it pleased His Majesty to order that the same should be taken into consideration by His Privy Council was published in the London Gazette one month at least before the said Petition was so considered:

Now, therefore, His Majesty, in pursuance and exercise of the powers in Him vested by the Municipal Corporations Acts, 1882: and 1893, the Borough Councillors (Alteration of Number) Act, 1925, and by the Birmingham Extension Act, 1927, and of every other power enabling Him in that behalf, doth, by and with the advice of His Privy Council, order and direct that:—

- 1. The number of Councillors of the said Perry Barr Ward shall be increased from one to three.
- 2.—(1) The two additional Councillors of the said Ward shall be elected on the first day of November, 1933, and the election shall be conducted by the same persons and in the same manner as an ordinary election of Councillors of the City.

(2) The Councillor elected by the larger number of votes shall retire on the first day of November, 1936, and the other Councillor shall retire on the second day of November, 1935.

3. The election of the additional Alderman made necessary by the increase in the number of Councillors of the City shall take place at the next ordinary election of Aldermen of the City after the date of this Order and the additional Alderman so elected shall retire on the ordinary day of election of Aldermen in the year 1939.

4. If for any reason it is doubtful which of the additional Councillors elected in pursuance of this Order ought to retire in the years specified in this Order, the question shall be determined at the first or second meeting of the Council after the election by lot under the direction of the Lord Mayor or other person presiding at that meeting.

WHEREAS by the Extradition Acts, 1870 (33 and 34 Vict. c. 52) to 1906 (6 Edw. VII. c. 15), it was amongst other things enacted that, where an arrangement has been made with any foreign State with respect to the surrender to such State of any fugitive criminals, His Majesty may, by Order in Council, direct that the said Acts shall apply in the case of such foreign State; and that His Majesty may, by the same or any subsequent Order, limit the operation of the Order, and restrict the same to fugitive criminals who are in or suspected of being in the part of His Majesty's dominions specified in the Order, and render the operation thereof subject to such conditions, exceptions and qualifications as may be deemed expedient:
