The Secretary of State for the Home Department gives notice that on the 12th instant, in pursuance of Section 6 of the Petroleum (Consolidation) Act, 1928, as applied by Order in Council dated the 20th July, 1930, he made the Compressed Gas Cylinders (Fuel for Motor Vehicles) Provisional Regulations, 1933, for the conveyance by road of cylinders which (i) contain any of the gases specified in the First Schedule to the Regulations in a compressed state, i.e. coal gas, carbon monoxide, hydrogen or methane, and (ii) are fitted to a motor vehicle solely for the purpose of storage of gaseous fuel under pressure for the propulsion of the vehicle.

The Secretary of State has also certified in pursuance of Section 2 of the Rules Publication Act, 1893, that on account of urgency the Regulations shall come into operation forthwith as provisional rules.
