NOTICE AS TO SUBMISSION OF CLAIMS TO NICARAGUAN CLAIMS COMMISSION.

The following is a translation of the first two articles of a Nicaraguan decree published in Gazette No. 179 of the 18th August, 1933:—

Article 1.—The Claims Commission established by law dated the 6th February, 1930, is to have jurisdiction and competence to take cognizance of all claims against the Government for payments or indemnities which have not been previously decided by the tribunal in question, and which are not in respect of salaries or services covered by the budget later than the creation of the said tribunal, nor for sums voted by the

National Congress for the payment of war losses and requisitions which must be inscribed in the register instituted by Executive Decree of the 11th March last.

Article 2.—Parties interested in making recoveries from the State on account of voluntary loans, even though at the time of their contraction a form of payment may have been established, or of forced loans, or war exactions, requisitions or damages, occasioned as from dates subsequent to the 30th June, 1927, for which the Commission considers that it is not competent, or for any other obligation, distinct from those mentioned, which might be attributed to the State, must present their claims within the final period of four months counting from the publication of the present law, and if they do not do so within this period in the manner already laid down in the regulations issued by the Commission they will lose all rights which they might have for the recognition or payment of their claims.
