

At the Court at *Buckingham Palace*, the 10th day of *November*, 1933.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 12th day of October, 1933, in the words and figures following, that is to say:—

“ We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for altering the boundaries of the Parishes of the Benefices of Taunton, Saint Mary Magdalene; Bishop's Hull, Saint John; Wilton; and Bishop's Hull, Saint Peter and Saint Paul; all of which Benefices are situate in the County of Somerset and in the Diocese of Bath and Wells:

“ Whereas Commissioners appointed at our request by the Right Reverend St. John Basil Wynne, Bishop of Bath and Wells, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire and report (*inter alia*) as to certain alterations of the boundaries of the said Parishes of Taunton, Saint Mary Magdalene; Bishop's Hull, Saint John; and Wilton; duly made their Report to the said Bishop of Bath and Wells and therein recommended certain alterations of boundaries affecting the said Parishes of Taunton, Saint Mary Magdalene; Bishop's Hull, Saint John; and Wilton; and also affecting the said Parish of Bishop's Hull, Saint Peter and Saint Paul, and the said Bishop of Bath and Wells signified in writing his approval of the said Report:

“ And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the said alterations of boundaries which Scheme is based upon the terms recommended in the said Report:

“ And whereas all of the Benefices of Taunton, Saint Mary Magdalene; Bishop's Hull, Saint John; Wilton; and Bishop's Hull, Saint

Peter and Saint Paul; are now full, the Reverend John Ernest Goodman Sweetnam being the present Incumbent of the said Benefice of Taunton, Saint Mary Magdalene; the Reverend Francis Edward Spurway being the present Incumbent of the said Benefice of Bishop's Hull, Saint John; the Reverend Hugh Parnell being the present Incumbent of the said Benefice of Wilton; and the Reverend George Fergusson Cockburn Raban being the present Incumbent of the said Benefice of Bishop's Hull, Saint Peter and Saint Paul:

“ And whereas the said George Fergusson Cockburn Raban is also the Patron of the said Benefice of Bishop's Hull, Saint Peter and Saint Paul:

“ Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said St. John Basil Wynne, Bishop of Bath and Wells (in testimony whereof he has signed this Scheme), and with the consents of the said John Ernest Goodman Sweetnam, Francis Edward Spurway, Hugh Parnell and George Fergusson Cockburn Raban (testified by their respectively signing this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

“ That upon the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council affirming this Scheme the portions of the Parishes described in the 1st Column of the Schedule hereto annexed (all which portions are delineated and set forth upon the Map or Plan hereto annexed and thereon coloured and hatched respectively as stated in the 2nd Column of the said Schedule) shall be severed from the Parishes of the Benefices of which they now form part and shall for all ecclesiastical purposes be annexed respectively to the Parishes stated in the 3rd Column of the said Schedule.

“ Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament.
