##### SUBJECT.

*Contraction of the Derbyshire Foot-and-Mouth Disease Infected Area.*

Substitutes on the 15th November, 1933, the following Area for the Infected Area described in the Schedule to the Foot-and-Mouth Disease (Infected Areas) Order of 1933 (No. 80):—

An Area comprising:—

*In the county of Derby.*

The parishes of Wensley and Snitterton, Tansley, Dethick Lea and Holloway, Bonsall, Ivonbrook Grange, Matlock, Matlock Bath, Cromford, Ible, Middleton by Wirksworth, Hopton and Griffie Grange, Carsington, Callow, Wirksworth, including its detached part, Kirk Ireton, Idridgehay and Alton, Biggin, Hognaston, Atlow, Bradbourne, Hulland, Hulland Ward, Hulland Ward Intakes, Turnditch, Crich, Alderwasley, Ashleyhay, Shottle and Postern, Hazelwood, Milford, Belper, Heage, so much of the parish of South Wingfield as lies to the west of the railway which runs from Ambergate Junction via Wingfield Station to Stretton and so much of the parish of Brassington as lies to the south and east of the road which runs from Winster via Wigley meadow Farm, Curzon Lodge, Longcliffe, White Edge and Hipecy Hill to Lea Hall.

##### SWINTON AND PENDLEBURY (No. 2) PLANNING SCHEME.

**N**OTICE is hereby given that (1) on the first day of November, 1933, the Minister of Health notified his approval of the resolution of the Council of the Urban District of Swinton and Pendlebury dated the eleventh

day of September, 1933, deciding to prepare the above planning scheme with reference to an area situate wholly within the Urban District of Swinton and Pendlebury; (2) the said Council having delegated powers in connection with the adoption and preparation of the scheme to the Manchester and District Regional Planning Committee the Map defining the area to which the resolution applies has been deposited at the Regional Planning Office, Town Hall, Manchester, and will be open for inspection each week-day by all persons interested without charge between the hours of 9 a.m. and 5 p.m. except on Saturdays when the hours will be 9 a.m. and 12 noon; (3) any person who is, or claims to be, an owner of any property in the area and any association representing owners of property within the said Urban District and any local association representing business or industry may by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the Manchester and District Regional Planning Committee, whose office is situate at the Town Hall, Manchester, to register without charge his or their name and address for the service of subsequent notices relating to the scheme; (4) under the Town and Country Planning (General Interim Development) Order, 1933,\* the development of land in the area during the preparation of the scheme is permitted to the extent specified in the Order and in addition the Council of the said Urban District are empowered to permit other development in the area during this period, with a view in either case to protecting the development from the risk of removal or alteration without compensation under the scheme when approved and in operation. A print of the Order has been deposited together with the aforesaid Map; (5) the Manchester and District Regional Planning Committee intend to proceed as soon as may be with the preparation of a Draft Scheme and any suggestions as to the proposals to be included in the Draft Scheme should be sent in writing to the Honorary Clerk to the Committee.
