Now, therefore, the Registrar-General of Births, Deaths and Marriages in England, in exercise of the powers conferred by Sections 10 and 11 of the Births and Deaths Registration Act, 1837, Section 21 of the Births and Deaths Registration Act, 1874, Section 21 (2) of the Local Government Act, 1929, and of all other powers in that behalf, with the approval and sanction of the Minister of Health, hereby orders as follows:—

- 1.—(1) This Order may be cited as the Parts of Kesteven, Rutland, Soke of Peterborough, Parts of Holland, Huntingdon, Isle of Ely, Leicestershire, Parts of Lindsey, and Northamptonshire Registration of Births etc., Order, 1933, and shall come into operation on the 1st day of January, 1934.
- (2) In this Order the term "district" means a superintendent registrars' district, and the terms "existing district" and "existing sub-district" mean a district or sub-district which existed immediately before the 1st day of January, 1934.
2. The parishes specified in the first column of the Schedule hereto (being situate in the counties specified in the second column thereof) shall be united with or be constituted the districts specified in the third column thereof and shall be added to and form part of or be constituted the sub-districts specified in the fourth column thereof.
3. The parishes of Bardney, Cherry Willingham, Fiskerton, Greetwell, Reepham and

Stainfield, hitherto comprised in the existing Lincoln South-West Sub-district of the Lincoln district shall be added to and form part of the Lincoln North-East sub-district of that district.

4. The districts and the sub-districts constituted under Article 2 of this Order shall be designated by the names respectively appearing in the third and fourth columns of the Schedule hereto.
5. The superintendent registrar and any registrar of marriages of any existing district with which another district is united by virtue of Article 2 of this Order shall respectively be the superintendent registrar or a registrar of marriages of the united district.
6. The registrar of any existing sub-district which is extended by this Order shall be the registrar of that sub-district as so extended.
7. The functions under the Registration Acts in relation to any parish specified in the first column of the Schedule hereto are hereby transferred to the Council of the County specified in the second column of the said Schedule.
