## SUPPLEMENTAL AND TEMPORARY CLAUSES.

Statute XV. 17.—At the end of this clause (XV. 17) the following words shall be added:

"And such reasonable anticipation shall be deemed to include and to have always included the anticipation that the Policy taken out by the President and Fellows on his behalf under Clause 5 of Statute X of 1915 would become his absolute property or the absolute property of his legal personal representatives as the case may be immediately upon the happening of any of the following events, that is to say,

(i) If he shall die while holding the Fellowship in virtue of which the policy was taken out.

(ii) If he shall cease to hold the Fellowship in virtue of which the policy was taken out by reason of his leaving the service of the College.

(iii) If he shall vacate the office in which he shall be serving the College in order to undertake some other work in the service of the College.

Provided that, if a Fellow continue in the service of the College in another capacity in which he shall be pensionable, the College may at its discretion retain the policy in question with a view to its employment under an amended contract with the Insurance Company to cover the liability of the College in regard to the new engagement undertaken by the Fellow.

But under no circumstances shall the rights of the Fellow be less than they would have been in the event of his death or retirement or of his claiming immediate enjoyment of the policy at the moment before his entering upon his new period of work in a different capacity in the service of the College.

(iv) If he shall reach the age of 57 while engaged in the work of an Official Fellow as Tutor in the service of the College.

In this last event the College may continue the Fellow in his Official work without being under any liability as to pension during the period before the Fellow shall reach the age for retirement and shall retire, the policy and all rights in respect of it being accepted by the Fellow at the age of 57 in full discharge of all pension claims present or future against the College."
