DANGEROUS DRUGS ACTS, 1920-1932.

The Secretary of State for the Home Department gives notice that, in conformity with the provisions of the International Convention of 1931 for limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, he has made Regulations in pursuance of subsection (3) of Section 2 of the Dangerous Drugs Act, 1932, for controlling the manufacture, possession and wholesale distribution of methylmorphine (commonly known as codeine), ethylmorphine (commonly known as dionin) and their respective salts.

The Regulations which are dated 15th December, 1933, come into force on 1st January, 1934, and are in substantially the same form as the Draft Regulations of which notice was given in the London Gazette and Edinburgh Gazette of the 3rd November, 1933.
