of the case shall seem to us and to the Bishop of Southwell equitable and proper. Provided always that it shall be lawful for us, if we shall see fit so to do in all or any of these cases to advance the compensation money or any part thereof out of the Expenses Fund of the Diocese of Southwell established pursuant to the 32nd Section of the said Union of Benefices Measure, 1923.

"5. That upon the said union taking effect the Parsonage House at present belonging to the said Benefice of Nottingham, Saint Peter, shall become and be the house of residence for the Incumbent of the United Benefice.

"6.—(a) That after the said union has taken effect the Church of Nottingham, Saint James, shall continue to be used for the purposes of Divine Service unless and until the Bishop of Southwell shall certify in writing to us, the said Ecclesiastical Commissioners, that the said Church is no longer required for such purposes and the said Church shall so soon as may be after the receipt by us of the said certificate from the Bishop be taken down and the materials and site thereof, together with any ground annexed thereto and necessary for the use and enjoyment thereof shall be sold and disposed of by us, the said Ecclesiastical Commissioners, at such time or times and in such manner in all respects as to us shall seem expedient subject to the conditions and restrictions imposed by the said Union of Benefices Measure, 1923.

"(b) That the net proceeds to arise from such sale or sales after the appropriation to the Expenses Fund of the Diocese of Southwell under the said Measure of so much of such proceeds as may in our opinion be necessary to defray the expenses attendant upon the sale or sales, the taking down of the Church, the removal of monuments (if any) and all other expenses incidental to these matters, shall be applied by us the said Ecclesiastical Commissioners as follows, that is to say (1) in payment thereout of the compensation or compensations mentioned in Clause 5 of this Scheme or in repayment of any advance made for the purpose of such compensation or compensations as in the same Clause is provided (2) as to such a sum as shall be determined by us, the said Ecclesiastical Commissioners, with the consent of the Bishop of Southwell, for and towards the augmentation of the United Benefice and (3) the residue of such net proceeds shall be held and accumulated by us as a fund for and towards the purchase of a suitable site for and the erection of a new Church for a District to be selected by the Bishop of Southwell as the District for which such Church shall be built; and any ultimate residue after the provision of a site for and the erection of such Church shall be added to the said Expenses Fund of the Diocese of Southwell.

"(c) That the font, communion table and plate used for the purpose of the Holy Communion in the said Church of Nottingham, Saint James, shall in accordance with the provisions of the said Measure and as the Bishop of the Diocese may direct be transferred to the Church of Nottingham, Saint Peter, being the Parish Church of the United Benefice or to some other Church or Churches within the Diocese of Southwell and the bells, organ and other furniture and fittings of the said Church of Nottingham, Saint James, or such of them

as the Bishop of Southwell shall select, shall be transferred to the Parish Church of the United Benefice, and any articles not so transferred shall be appropriated by the Bishop of Southwell for use in the proposed Church of the said District or be removed to any other Church or Chapel or Churches or Chapels within the Diocese of Southwell which the Bishop may select or shall be sold and in such case the proceeds shall be added to the fund arising from the sale of the site and materials of the said Church of Nottingham, Saint James as aforesaid.

"(d) That upon the Bishop certifying in writing as aforesaid that the said Church of Nottingham, Saint James, is no longer required for the purposes of Divine Service the Register Books of baptisms, marriages and burials and other the records and muniments deposited in the said Church of Nottingham, Saint James, shall be transferred to the Church of Nottingham, Saint Peter, but the marriage registers in duplicate current at the said Church of Nottingham, Saint James, shall first be sent by the Incumbent of the United Benefice to the Registrar General to be closed officially.

"7. That upon the union taking effect the endowments of the United Benefice (apart from any augmentation under the provisions of the last preceding clause of this Scheme) shall consist of the whole of the endowments of the said Benefices of Nottingham, Saint Peter, and Nottingham, Saint James, and a part of the endowments of the said Benefice of Nottingham, Saint John the Baptist, namely all the endowments of the last named Benefice, except an annual sum of £250 being part of a larger annual sum now payable by us, the said Ecclesiastical Commissioners, to the Incumbent of that Benefice, and the endowment of the said Benefice of Nottingham, Saint John the Baptist, shall consist of the annual sum of £250 so excepted.

"Provided always that the provisions herein contained relating to the sale and disposal of the Church of Nottingham, Saint James, shall not take effect until the consents and approval, which by the said Union of Benefices Measure, 1923, are made requisite to the sale under the powers conferred by that Measure of the site of any Church, shall be obtained to the sale and disposal hereby proposed of the said Church of Nottingham, Saint James, and of the site thereof together with any ground annexed or belonging thereto.

"And provided further that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:
