STATUTE APPROVED BY CONGREGATION ON
TUESDAY, 28TH NOVEMBER, 1933.

Whereas it is expedient to amend § 4 of Section 1 of Title IV of the Statutes of the University of Oxford in order that it may conform with alterations in the Statutes made by the University establishing a Chair of Egyptology: Now the said University, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, enacts, subject to the approval of His Majesty in Council, as follows:

In *Statt. Tit. IV. Sect. 1*, in the Schedule annexed to § 4 (*Statuta*, ed. 1933, p. 62, l. 43), immediately before the words "Professor of Comparative Philology . . . 900" the words "Professor of Egyptology . . . 1,000" shall be inserted.

STATUTE APPROVED BY CONGREGATION ON
TUESDAY, 28TH NOVEMBER, 1933.

Whereas it is expedient to transfer the Professor of Comparative Philology from Schedule B to Schedule A of the Schedules annexed to *Statt. Tit. IV. Sect. 1. § 3* and to increase the stipend by £100: Now the University, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, enacts, subject to the approval of His Majesty in Council, as follows:

1. In *Statt. Tit. IV. Sect. 1* (*Statuta*, ed. 1933, p. 60, after l. 6) add "Professor of Comparative Philology".
2. *Ibid.* (p. 60, l. 14) strike out the words "Professor of Comparative Philology".
