

sales and to enact all such incidental or consequential provisions as may be necessary or convenient.

To make provision as to the consideration for each such purchase and sale or transfer and vesting, and as to the debts and liabilities of and moneys due or accrued due to the Vendors.

To make provision for the creation of consolidated ordinary stock of the Company to the amount requisite for each such purchase and sale or transfer and vesting and to define the rights and priorities of the stock so created.

To provide for the dissolution of the Vendors and the winding up of their affairs.

To make provision for the payment of cash in lieu of the issue of fractional parts of one pound of consolidated ordinary stock of the Company and with respect to securities of the Vendors held by and securities of the Company and sums in cash to be issued to trustees and others in a fiduciary capacity.

To make provision as to the payment of dividends on the capital of the Vendors and as to dividends on the consolidated ordinary stock of the Company to be substituted for such capital.

To provide for the continuance of certain of the provisions of the Acts and Orders relating to the Vendors and for the repeal of the remainder of the said provisions.

To make provisions as to the compensation to be paid to the directors and auditors of the Vendors.

To make provisions as to the employment by the Company of the officers servants and workmen of the Vendors and the compensation to be paid to such officers servants and workmen or some of them in certain cases.

To extend the limits within which the Company are authorised to supply gas so as to include the following areas (hereinafter referred to as "the added areas") in the County of Somerset—

The urban district of Burnham-on-Sea.  
In the rural district of Bridgwater—  
The parish of Huntspill.

In the rural district of Axbridge—  
The parish of Burnham Without.

So much of the parish of Berrow as is comprised within the limits within which the Burnham Gas Company Limited are authorised to supply gas (that is to say):—

So much of that parish as is situate southward of an imaginary line drawn from a point where the boundary between the parishes of Brean and Berrow commences on the sea-shore thence along that boundary to its south-eastern corner thence in a straight line to the northernmost point of North Lane thence in a south-easterly direction along the north-eastern side of North Lane to Ford Common thence across Ford Common in a straight line to Green Lane thence along the north-eastern side of Green Lane to the boundary between the parishes of Berrow and Brent Knoll.

So much of the parish of Brent Knoll as is comprised within the limits within which the Burnham Gas Company Limited are authorised to supply gas (that is to say):—

So much of that parish as is situate southward and westward of an imaginary line

commencing on the boundary between that parish and the urban district of Burnham-on-Sea at or near the point where Berrow Lane crosses Pitland Rhyne and drawn thence in an easterly direction along and including Berrow Lane to the Great Western Railway and thence in a southerly direction along and including that railway to the boundary between the parishes of Burnham Without and Brent Knoll.

To authorise the Company to exercise within the added areas all or some of the powers rights and privileges exercisable by them within their existing limits of supply.

To make provision as to the price to be charged by the Company for gas supplied in the added areas and to authorise the charging for gas supplied in those areas respectively of prices exceeding those charged in the Company's existing limits or any part thereof.

To authorise the Company to hold and use for the purposes of their undertaking the lands hereinafter mentioned and on the said lands to maintain, alter, improve, extend, renew and use the existing gasworks and other works on those lands and to erect, maintain, alter and use or discontinue new or additional gasworks machinery and other apparatus and to store gas and convert and manufacture the residual products of gas.

The lands above referred to are the lands which form the respective sites of the existing gasworks of the Vendors and upon which the Vendors are authorised to manufacture and store gas. The said lands comprise—

(a) A piece or parcel of land belonging or reputed to belong to and in the occupation of the Burnham Gas Company Limited and upon which the existing gasworks of that Company are erected situate in the urban district of Burnham-on-Sea in the County of Somerset bounded on the south and east in part by lands and premises belonging or reputed to belong to Eva Ann Hicks and in part by lands and premises forming the back gardens of dwellinghouses in Jaycroft Road, on the north in part by lands and premises belonging or reputed to belong to Holt Brothers Limited in part by lands and premises forming the back gardens of dwellinghouses in Dunstan Road and in other part by lands and premises belonging or reputed to belong to John Phillips Board, Charles Edward Barry and Arthur Phillips Board and on the west in part by lands and premises belonging or reputed to belong to Holt Brothers Limited and in part by the Highway known as Oxford Street;

(b) A piece or parcel of land belonging or reputed to belong to and in the occupation of the Highbridge Gas Company Limited and upon which the existing gasworks of that Company are erected situate at Highbridge in the urban district of Burnham-on-Sea in the County of Somerset containing 5491 superficial square yards or thereabouts bounded on the south and west by lands and premises belonging or reputed to belong to Messrs. Cox & Company Limited, on the north by a public road called or known as Springfield Road Highbridge aforesaid and on the east by the Great Western Railway.

To empower the Company to raise money by borrowing on mortgage of their undertaking
