THE GAS FUND (CONTRIBUTION) ORDER, 1934, DATED JANUARY 2, 1934, MADE BY THE BOARD OF TRADE UNDER SECTION 7 OF THE GAS REGULATION ACT, 1920 (10 & 11 GEO. 5. C. 28).

In pursuance of the powers conferred upon them by Section 7 of the Gas Regulation Act, 1920, and of all other powers enabling them in that behalf, the Board of Trade hereby prescribe as follows:

1. The rate of contribution to the Gas Fund for the year 1934 shall be one shilling and one penny for each million cubic feet of gas sold during the year 1933.

2. Such contribution shall be paid on or before the 1st April, 1934, to the Board of Trade at Great George Street, London, S.W.1, by all Gas Undertakers with respect to whom an Order under the said Act shall have been made or to whom sub-section (3) of Section 7 of the said Act applies by virtue of any public general Act, Special Act, or Special Order.

3. Payment of the contribution shall be by cheque made payable to the "Board of Trade" and crossed "Bank of England."

4. This Order may be cited as the Gas Fund (Contribution) Order, 1934.

EXPLOSIVES IN COAL MINES.

The Secretary for Mines gives notice that, under Section 61 of the Coal Mines Act, 1911, the Board of Trade have made an Order entitled the Explosives in Coal Mines Order, 1934, regulating the Supply, Use and Storage of Explosives at mines under that Act.

This Order, which takes effect from 1st January, 1934, consolidates and re-enacts with amendments the Explosives in Coal Mines Orders on the 1st September, 1913, 30th March, 1915, 14th November, 1919, 31st August, 1922, 1st September, 1924, 10th November, 1926, 6th January, 23rd February and 21st December, 1932, which are revoked.

The Order also amends the definition of the term "permitted explosive," and in consequence the following Explosives in Coal Mines Orders amending the First and Second Schedules to the Explosives in Coal Mines

Order of the 1st September, 1913, are also revoked; Orders dated 29th July, 1924, 23rd September, 1925, 30th January and 14th July, 1926, 15th April and 26th August, 1930, 4th March and 21st December, 1931, 14th July, 31st August and 28th November, 1932.
