WHEAT ACT, 1932.

1934, varying the Wheat (Anticipated Supply) No. 1 Order, 1933, by prescribing 29 million cwt. instead of 27 million cwt. as the quantity of home-grown millable wheat of their own growing which he anticipates will be sold by registered growers during the cereal year beginning on the 1st August, 1933.

ABROGATION OF POWERS OF COMMISSIONERS OF SEWERS.

Constitution of Internal Drainage Districts.

Notice is hereby given that the Minister of Agriculture and Fisheries has made Orders under the Land Drainage Act, 1930, confirming the Orders made on the 21st December, 1933, in relation to the Schemes prepared by the River Avon (Bristol) Catchment Board, under Section 4 (1) (b) of the Act, making provision for the abrogation of the powers of the Somerset, the Ladden Brook Valley and the Lower Level of Gloucester Commissioners of Sewers so far as such powers are exercisable within the Catchment Area; the constitution of two Internal Drainage Districts viz. the Easton-in-Gordano and the Ladden Brook Valley and Yate Internal Drainage Districts; and for matters supplemental thereto.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.
