

DISEASES OF ANIMALS ACTS, 1894 TO 1927—*continued.*SHEEP SCAB MOVEMENT AREAS—*continued.*

*Cheshire, Lancashire, Derbyshire, and West Riding of Yorkshire.*—An Area comprising:—

The borough of Todmorden and so much of the counties of Chester, Lancaster, Derby, and West Riding of Yorkshire, the county boroughs of Rochdale, Oldham, Huddersfield and Halifax and the boroughs of Stalybridge, Glossop, Ashton under Lyne and Mossley (Manchester) as lies within the following boundary, namely:—

Commencing at the railway station at Deepcar; thence in a north-westerly direction along the road via Deepcar, Stocksbridge, Sheephouse Wood, Langsett to Flouch Inn; thence in a westerly direction via Fiddlers Green and Saltersbrook Bridge to the point where the road crosses the London and North Eastern Railway from Penistone to Glossop near the western end of Woodhead Tunnel; thence along the London and North Eastern Railway via Growden to Glossop railway station; thence in a southerly direction along the road until it meets the road from Sheffield to Stalybridge; thence in a north-westerly direction along the road via Brookfield, Lane Ends, and Roe Cross to Stalybridge; thence in a westerly direction along the road to Ashton under Lyne; thence in a northerly direction along the road via Bardsley, Oldham, Royton and Balderstone to Rochdale; thence in a general north-easterly direction via Smallbridge, Dearnley, Littleborough, Warland, Walsden, Todmorden, and Eastwood to Hebden Bridge; thence in a general south-easterly direction along the road via Mytholmroyd, Luddenden Foot, Sowerby Bridge, Copley, Elland, Ainleys, Birchencliffe, Edgerton, Huddersfield, Moldgreen, Tandem, Fenay Bridge, Highburton, Shelley Far Bank, Shepley, Park Head, Ingbirchworth and Penistone, to Penistone railway station, and thence along the London, Midland and Scottish Railway via Wortley Station to Deepcar Station and the point of commencement.

*Inverness.*—An Area comprising:—

The Islands known as the Outer Hebrides (*except the Islands of St. Kilda, Dune, Soay and Boreray*), in the county of Inverness.

*Ross and Cromarty.*—An Area comprising:—

The Island of Lewis, including the smaller islands adjacent thereto, in the county of Ross and Cromarty.

*Stirlingshire and Dunbartonshire.*—An Area comprising:—

1. The premises in the occupation of Arthur Nixon known as Corriearklet Farm, in the parish of Buchanan, in the county of Stirling.
2. The premises in the occupation of Arthur Nixon known as Dhu of Glengyle Farm, in the parish of Buchanan, in the county of Stirling.
3. The premises in the occupation of George Buchan known as Garrison Farm, in the parish of Buchanan, in the county of Stirling; and
4. The premises in the occupation of Donald McNicol known as Doune Farm, in the parish of Arrechar, in the county of Dunbarton.

An Area comprising:—

The county of Lancaster, including all county boroughs and other boroughs geographically situate therein (excepting the county borough of Barrow-in-Furness, and the petty sessional divisions of North Lonsdale and Hawkshead).
