"And whereas the Right Reverend Martin, now Bishop of Rochester, and the Reverend Henry James Powell now Rector or Incumbent of the said Rectory of Milton-next-Gravesend, have respectively signified to us their desire that the Patronage of the said two Benefices of Chalk and Christ Church, Milton, may be rearranged by way of exchange in the manner which is hereinafter recommended and proposed:

"And whereas we have made due inquiry and calculation as to the circumstances and relative value of the said two Benefices and of the Patronage thereof respectively and we do hereby certify to Your Majesty in Council that the circumstances and present values of the said two Benefices are as set forth in the Schedule hereunto annexed:

"Now, therefore, with the consent of the said Martin, Bishop of Rochester, acting as such Bishop (in testimony whereof he has affixed his signature and Episcopal Seal to this Scheme), and with the consent of the said Henry James Powell, Rector or Incumbent of the said Rectory of Milton-next-Gravesend acting as such Rector or Incumbent (in testimony whereof he has signed and sealed this Scheme), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council

ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Chalk and the Church thereof shall be assigned and transferred from the said Martin, Bishop of Rochester, and from his successors in the same Bishopric and shall become and be absolutely vested in and shall and may from time to time and at all times be exercised by the said Henry James Powell, Rector or Incumbent of the said Rectory of Milton-next-Gravesend and his successors Rectors or Incumbents of the said Rectory for ever and that in exchange for the same the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Christ Church, Milton, and the Church thereof shall in like manner and upon and from the same date be assigned and transferred from the said Henry James Powell, Rector or Incumbent of the said Rectory of Milton-next-Gravesend, and from his successors Rectors or Incumbents of the same Rectory and shall become and be absolutely vested in and shall and may from time to time and at all times be exercised by the said Martin, Bishop of Rochester, and his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of either of them, or of any other Act of Parliament.
