MORECAMBE AND HEYSHAM GAS.

(Application for Special Order under the Gas Undertakings Acts, 1920 and 1929.)

NOTICE is hereby given that application is intended to be made forthwith to the Board of Trade by the Mayor Aldermen and Burgesses of the Borough of Morecambe and Heysham (hereinafter referred to as "the Corporation") whose address is the Town Hall, Morecambe and Heysham, in the County Palatine of Lancaster, for a Special Order under the Gas Undertakings Acts, 1920 and 1929 (hereinafter called "the Order") for all or some of the following purposes, that is to say:—

1. To authorise the Corporation upon the lands hereinafter described, or some part or parts thereof, to erect, maintain, alter, improve, extend, renew or discontinue gas works, machinery and other apparatus and works for the manufacture, storage, conversion, utilisation, and distribution of gas and of residual products arising from such manufacture, and to make and store gas, and to make, use, store, utilise, work up, convert, purchase, and distribute all such residual products and materials as aforesaid. The lands hereinbefore referred to are situate in the Borough of Morecambe and Heysham and County Palatine of Lancaster and are :—

A piece of land containing by admeasurement twenty acres three roods twenty-three perches or thereabouts situate in the Borough of Morecambe and Heysham being the enclosures numbered 871, 872, 873, 874, 875, 876, 880, 881, 882, 934, 927, 926, on the 1/2500 Ordnance Map, Sheet XXX 5, 1933 edition, and a small triangular piece of land (unnumbered) adjoining the Heysham branch of the London Midland and Scottish Railway and the roadway numbered 925 on the said Ordnance May the whole being bounded on the north west by the said railway, on the east by Out Moss Lane, on the south by enclosures numbered 877 and 879 and on the west by enclosures numbered 877 and 883 on the said Ordnance Map.

2. To empower the Corporation by Agreement to purchase, take and hold lands and easements.

3. To confer powers upon the Corporation with reference to the retention sale and disposal of lands acquired by them for the purposes of their gas undertaking.

4. To extend the limits within which the Corporation are authorised to supply gas so as to include the parish or township of Bolton-le-Sands in the rural district of Lancaster in the County of Lancaster and to authorise the Corporation to have and exercise within such parish or township (hereinafter called "the new limits") all powers rights and privileges which they have or may exercise within their existing limits of supply.

5. To make provision as to the price or prices to be charged for gas within the new limits.

6. To authorise the Corporation to borrow moneys for all or any of the purposes of the Order.

7. To enable the Corporation to exercise all such powers as may be necessary or convenient for the purposes of the Order and to confer upon the Corporation all such other powers, as are now usually conferred upon Local Authorities in connection with the supply of gas.

8. To vary or extinguish all or, any rights and privileges inconsistent with or which would or might impede or interfere with the objects of the Order and to confer other rights and privileges.

9. To repeal, alter, or amend, or to re-enact or incorporate in the Order with or without amendment some or all of the provisions of the Lands Clauses Acts, the Gasworks Clauses Acts, 1847 and 1871, the Morecambe Urban District Council (Gas) Act, 1900, the Morecambe Corporation Act, 1918, the Morecambe Gas (Charges) Order, 1923, the Morecambe Corporation Act, 1924, the Morecambe Gas Order; 1924, and the Morecambe Corporation Act, 1928, and any other Act or Order relating to the undertaking.

Any local or other public authority, Company, or person desiring to bring before the Board of Trade any objection to the draft Order may do so by registered letter, addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W.1, and despatched on or before the 10th day of April, 1934. Any such objection shall state :--

(a) the specific grounds of objection, and (b) the omissions, additions, or modifications asked for.

A copy of the objection shall be forwarded to the Applicants for the Order or their Agents at the same time as it is sent to the Board of Trade.
