7. To provide that all works established and contracts and agreements (except the said Deed of Transfer) entered into under the said Orders of 1900 and 1907 shall be deemed to have been established and entered into under the provisions of the Order.

To confer upon the Company all or some of the powers of the Electricity (Supply) Acts 1882 to 1933 and the enactments incorporated therewith and to alter vary or extinguish all rights and privileges which would or might interfere with any of the objects of the Order and to confer all other rights and privileges necessary for carrying such objects into effect.
