IN ENGLAND.

(Dated 12th March, 1934.)

Whereas the city and county borough of Canterbury, now co-extensive with the superintendent registrar's district of Canterbury, will, on the 1st day of April, 1934, by virtue of the provisions of the Canterbury Extension Act, 1933, be extended to include parts of certain parishes situate in the administrative county of Kent and comprised in the superintendent registrars' districts of Blean and Bridge;

And whereas it is expedient that the city and county borough of Canterbury as extended should be wholly comprised within the superintendent registrar's district of Canterbury;

Now, therefore, the Registrar-General of Births, Deaths and Marriages in England, in exercise of the powers conferred by Sections 10 and 11 of the Births and Deaths Registration Act, 1837, Section 21 of the Births and Deaths Registration Act, 1874, and of all other powers in that behalf, with the approval and sanction of the Minister of Health, hereby orders as follows:-

- 1.—(1) This Order may be cited as the Canterbury and County of Kent Registration of Births, etc., Order, 1934, and shall come into operation on the 1st day of April, 1934.
- (2) In this Order the term "district" means a Superintendent Registrar's district, and the terms "existing district" and "existing sub-district" mean respectively existing sub-district" mean respectively a district and a sub-district which existed immediately before the 1st day of April,
- 2. That portion of the existing Blean district consisting of parts of the parishes of Hackington and St. Dunstan Without, and that portion of the existing Bridge district consisting of parts of the parishes of Harble-down and Thannington Without, which will by virtue of the provisions of the Canterbury Extension Act, 1933, be included on the 1st day of April, 1934, in the county borough of Canterbury, shall respectively become separate districts, and shall thereupon be united with the existing Canterbury district
- 3. The areas added by Article 2 of this Order to the Canterbury district shall cease to be included in the Whitstable and Bridge sub-districts and shall be added to and form part of the Canterbury sub-district.
- 4. The Superintendent Registrar of the existing Canterbury district, and the Registrar of Births and Deaths of the existing Canterbury sub-district, shall respectively be the Superintendent Registrar and the Registrar of Births and Deaths of the district and sub-district as extended by this Order.

ORDER OF THE REGISTRAR-GENERAL | ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated 7th March, 1934.)

Whereas under Section 11 of the Births and Deaths Registration Act, 1837, the Registrar-General, with the approval of the Minister of Health, may divide any superintendent registrar's district into two or more superintendent registrars' districts;

And whereas it is expedient that the Ormskirk superintendent registrar's district should be divided into two superintendent registrars' districts:

And whereas it is necessary to transfer the functions under the Registration Acts in relation to one of the superintendent registrars' districts so formed;

Now, therefore, the Registrar-General of Births, Deaths and Marriages in England, in exercise of the powers conferred by Section 11 of the Births and Deaths Registration Act, 1837, Section 21 (2) of the Local Government Act, 1929, and of all other powers in that behalf, with the approval and sanction of the Minister of Health, hereby orders as follows:-

- 1.—(1) This Order may be cited as the Ormskirk Registration of Births, etc., Order, 1934, and shall come into operation on the 1st day of April, 1934.
- (2) In this Order the term "district" means a superintendent registrar's district, and the term "existing district" means a district which existed immediately before the 1st day of April, 1934.
- -(1) The existing Ormskirk district shall be divided into two districts called respectively the Ormskirk and the Southport districts.
- (2) The Ormskirk district shall consist of that portion of the existing Ormskirk district which is situate within the County of Lancaster.
- (3) The Southport district shall consist of that portion of the existing Ormskirk district which is situate within the County Borough of Southport.
- 3. The superintendent registrar of the existing Ormskirk district shall be the superintendent registrar of the Ormskirk district as constituted by this Order.
- 4. The functions under the Registration Acts in relation to the Ormskirk district as constituted by this Order are hereby transferred to the Council of the County of Lancaster.
