

within the Protectorate, or, subject as aforesaid, may take such other disciplinary action as may seem to him desirable."

III. This Order shall come into operation forthwith.

IV. His Majesty may from time to time revoke, alter, add to or amend this Order.

And the Right Honourable Sir Philip Cunliffe-Lister, one of His Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 8th day of March, 1934, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the consecrated Church of Saint Oswald, Preesall, situate in the Parochial Chapelry of Stalmine, in the Parish of Lancaster, in the County of Lancaster and in the Diocese of Blackburn:

"Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint Oswald, Preesall, situate as aforesaid:

"Now, therefore, with the consent of the Right Reverend Percy Mark, Bishop of Blackburn (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said Parochial Chapelry of Stalmine which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Oswald, Preesall, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Oswald, Preesall.'

"And with the like consent of the said Percy Mark, Bishop of Blackburn (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears

to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said Church of Saint Oswald, Preesall, situate as aforesaid, and that the fees or dues to be received in respect of the publication of banns and of the solemnization or performance of marriages, churchings and burials should be paid and belong to the minister of the same church for the time being.

"THE SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Oswald, Preesall, being:—

"All that part of the Parochial Chapelry of Stalmine, in the Parish of Lancaster, in the County of Lancaster and in the Diocese of Blackburn, which is bounded upon the west by the New Parish of Saint Peter, Fleetwood, in the said County and Diocese, upon the north by the sea, upon the east by the Parochial Chapelry of Pilling, in the said County and Diocese, and upon the remaining side, that is to say, upon the south, by an imaginary line commencing at the point where the boundary which divides the said Parochial Chapelry of Pilling from the said Parochial Chapelry of Stalmine crosses the middle of Head Dyke Lane, and extending thence westward along the middle of Head Dyke Lane for a distance of 26 chains or thereabouts to its junction with the road leading past Pointer House Farm near the eastern end of a dyke running towards the lane called Cart Gate, and extending thence westward to and along the middle of the said dyke for a distance of 31 chains or thereabouts to the point where it reaches the eastern side of the road leading northward into Sandy Lane near the junction of such road with Cart Gate, and extending thence first south westward to the junction of such roads and then westward along the middle of Cart Gate for a distance in all of 24 chains or thereabouts to its junction with Park Lane and Lindel Lane, and extending thence south westward along the middle of Lindel Lane for a distance of 24 chains or thereabouts to its junction with Back Lane, and extending thence southward along the middle of Back Lane for a distance of 2½ chains or thereabouts to the point where it crosses the middle of the line of the mineral railway leading past the Preesall Salt Mines to Preesall Jetty, and extending thence westward along the middle of the said line of railway for a distance of 1 mile and 4 chains or thereabouts to the western end of Preesall Jetty, and extending thence in a straight line due west for a distance of 7 chains or thereabouts to a point in the middle of the River Wyre upon the boundary which divides the said Parochial Chapelry of Stalmine from the said New Parish of Saint Peter, Fleetwood."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order
