which they now belong and be annexed for ecclesiastical purposes to the Parish of Ferry Fryston, and those detached portions of the Parish of Pontefract Saint Giles coloured green and verged with red may be advantageously separated from that Parish to which they now belong and be annexed for ecclesiastical purposes to the adjoining Parish of Pontefract All Saints.

"That the said piece of land coloured pale blue on the said plan may be advantageously separated from the Parish of Pontefract All Saints to which it now belongs and be annexed for ecclesiastical purposes to the adjoining Parish of Carleton.

"That the said piece of land coloured pink on the said plan may be advantageously separated from the Parish of Carleton to which it now belongs and be annexed for ecclesiastical purposes to the adjoining Parish of Pontefract Saint Giles.

"That I, the said Bishop of Wakefield, am the Patron of the said Parish of Pontefract Saint Giles and the Reverend Cuthbert Charles Trewhitt Naters is the present Incumbent thereof.

"That I, the said Bishop of Wakefield, am the Patron of the Parish of Pontefract All Saints and the Reverend Arthur Granville Shipley is the present Incumbent thereof.

"That the said Reverend Cuthbert Charles Trewhitt Naters is the Patron of the said Parish of Carleton in right of his said Vicarage of Pontefract Saint Giles and the Reverend Charles Willoughby Gabb is the present Incumbent thereof.

"That the Sub-Chanter and Vicars Choral of the Cathedral and Metropolitical Church of Saint Peter in York are the Patrons of the said Parish of Ferry Fryston and the Reverend Ernest Marsh is the present Incumbent thereof.

"That I, the said Bishop of Wakefield, am the Patron of the Parish of Whitwood and the Reverend Coleman Watson North Ivens is the present Incumbent thereof.

"That I, the said Bishop of Wakefield, am the Patron of the said Parish of Whitwood Mere and the Reverend Job Maxwell Shaw is the present Incumbent thereof.

"That the Dean and Chapter of the Cathedral Church of Christ in Oxford are the Patrons of the Parish of Featherstone and the Reverend James Gray is the present Incumbent thereof, and all the above Patrons and Incumbents respectively consent to this Representation and to the Scheme hereinafter referred to.

"That pursuant to the direction of the 1st mentioned Act of Parliament I have drawn up a Scheme in writing appended to this Representation describing the mode in which it appears to me that the separation and annexations before proposed may be best effected and how the changes consequent thereon in respect to ecclesiastical jurisdiction Glebe lands tithes dues rates and payments and in respect to Patronage and rights to pews may be made with justice to all parties interested."

And whereas the said Scheme drawn up by the said Bishop and the Consents referred to in the Representation are as follows:--

## " SCHEME.

"It is proposed that the said portion of the Parish of Whitwood coloured blue on the plan

marked 'A' hereunto annexed shall be separated from that Parish to which it now belongs and be transferred for ecclesiastical purposes to the adjoining Parish of Whitwood Mere.

"That the said portion of the Parish of Featherstone coloured yellow on the said plan may be separated from that Parish and be annexed for ecclesiastical purposes to the adjoining Parish of Whitwood.

"That those detached portions of the Parish of Pontefract Saint Giles which are coloured green on the tracing marked 'B' annexed to the said plan shall be separated from that Parish and be annexed for ecclesiastical purposes to the adjoining Parish of Ferry Fryston.

"That those detached portions of the Parish of Pontefract Saint Giles which are coloured green and verged with red on the said tracing marked 'B' shall be transferred from that Parish and be annexed for ecclesiastical purposes to the adjoining Parish of Pontefract All Saints.

"That those extra Parochial areas coloured dark blue and adjoining the Parish of Pontefract Saint Giles shall be annexed for ecclesiastical purposes to that Parish.

"That that extra Parochial area and the part of Pontefract Saint Giles both coloured green on the said plan shall be annexed for ecclesiastical purposes to the adjoining Parish of Pontefract All Saints.

"That that portion of the Parish of Pontefract All Saints which is coloured mauve on the said plan shall be separated from that Parish and be annexed for ecclesiastical purposes to the adjoining Parish of Ferry Fryston.

"That that portion of the Parish of Ferry Fryston which is coloured brown on the said plan shall be separated from that Parish and be annexed for ecclesiastical purposes to the adjoining Parish of Pontefract All Saints.

"That that portion of the Parish of Pontefract All Saints coloured pale blue on the said plan shall be separated from that Parish and be annexed for ecclesiastical purposes to the adjoining Parish of Carleton.

"That that portion of the Parish of Carleton which is coloured pink on the said plan shall be separated from that Parish and be annexed for ecclesiastical purposes to the adjoining Parish of Pontefract Saint Giles.

"That no change shall be made by this Scheme in respect to the Glebe lands Tithes Rent charges or other endowments or emoluments of any of the Benefices of the said Parishes.

"That there shall be no change in the Patronage of any of the Benefices of the said Parishes.

"That the Parishioners of the said portions of the Parishes so transferred as aforesaid shall from the time of separation and annexation be exonerated from all liability for repair of the Parish Churches to which the said portions now belong and shall be liable for the repair of the Parish Churches to which the same are intended to be annexed as aforesaid subject to the provisions of the Compulsory Church Rates Abolition Act 1868.

"That the Parishioners of the portions so separated and annexed shall not after the
