

Statutes framed by the said Commissioners in relation to our said College in the following manner, viz. :—

By repealing Chapter XII, Section 17, of the Statutes so framed by the said Commissioners and approved by His Majesty The King in Council, on the 30th day of April, 1926, and by substituting therefor the following Statute :

The thirteen Fellows highest in order of precedence shall for the purposes of the settlement of Mr. Tancred be taken to be "the thirteen Fellows of Christ's College, in Cambridge, upon the Foundations of Margaret, Countess of Richmond and King Edward VI." The two Fellows next in order of precedence shall be called Fellows on the Foundation of Sir John Finch and Sir Thomas Baines. The Fellow sixteenth in order of precedence shall be called the Fellow on the Foundation of Dr. John Pierpont Morgan. Of the remaining Fellows, one in Class IV, if there be one, and if not, the Fellow seventeenth in order of precedence, shall be called the Fellow on the Foundation of Sir Arthur Everett Shipley. The others shall be called Fellows on the Foundation of the Lady Margaret, Countess of Richmond and Derby, Foundress of the College, or on such other Foundations as may be hereafter established.
