RIVER TRENT CATCHMENT BOARD.

*Armthorpe Internal Drainage District.*

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming a scheme submitted to him by the River Trent Catchment Board under Section 4 (1) (b) of the Act, making provision for the alteration of the boundaries of the Armthorpe Internal Drainage District, and that the Order will become final and have effect as an Act of Parliament, unless within thirty days from the date of this notice a Memorial that the Order shall not become law without confirmation by Parliament is presented to the Minister by some person or body affected by the Order, and having an interest sufficient for the presentation of a Memorial.

LANEHAM INTERNAL DRAINAGE BOARD.

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming the Order made on the 11th April, 1934, in relation to the Scheme prepared by the River Trent Catchment Board, under Section 4 (1) (b) of the Act, for the re-construction of the Laneham Internal Drainage Board.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the

Order is not within the powers of the Act or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.
