WHEREAS by the Military Manœuvres Acts, 1897 and 1911, it is enacted that His Majesty may, by Order in Council, authorize the execution of military manœuvres within specified limits during a specified period not exceeding three months:

Now, therefore, His Majesty, by and with the advice of His Privy Council, by virtue of the power for this purpose given to His Majesty by the said Acts, and of every other power hereunto enabling Him, doth hereby authorize the execution of military manœuvres within the limits specified in the Schedule to this Order during the period of two calendar months commencing from the 15th day of August, 1934.

And the Right Honourable the Viscount Hailsham, one of His Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

SCHEDULE.

All that part of the County of the East Riding of Yorkshire lying within a line drawn as follows, excluding where any road, track or railway line is named as a boundary, the said road, track or railway line:—

On the North, due eastwards from the cross-roads three and a half miles due north of Langtoft and just south of Foundry Foxholes to the coast at a point between Gull Nook and North Cliff, Flamborough Head.

On the East, southwards from this point along the coast to a point opposite Kilnsea Village (3½ miles north of Spurn Head).

On the South, from this point along the road to Kilnsea; thence along the northern bank or limit of the River Humber to the point where it is crossed by the boundary of Kingston upon Hull; thence along the boundary of Kingston upon Hull, as it existed prior to April, 1930, first northwards to the vicinity of Somerden House, then generally westwards to the point where that boundary diverged from the Cottingham Road; thence along this road to Cottingham.

On the West, along the Hull and Scarborough branch of the L. and N.E. Railway northwards from the point where it is crossed by the road from Kingston upon Hull just south of Cottingham Station to approximately ¼ of a mile beyond Great Driffeld Railway Station; thence along the road northward to and through Langtoft to the aforesaid cross-roads just south of Foundry Foxholes.
