The Unemployment Insurance Statutory Committee give notice that the following draft regulations have been submitted to them by the Minister of Labour under the Unemployment Insurance Act, 1934, namely, The Unemployment Insurance (Benefit Miscellaneous Provisions) Regulations, 1934; the Unemployment Insurance (Joint Maintenance of Dependents) Regulations, 1934; the Unemployment Insurance (Courts of Referees) (Amendment) Regulations, 1934; and the Unemployment Insurance (Associations) (Amendment) Regulations, 1934.
