"And whereas Your Majesty was graciously pleased by Your Order in Council bearing date the 17th day of March, 1932, to sanction the appointment of a Chief Constable, Royal Marine Police, with salary, amongst other conditions of service set forth therein, at the standard rate of £1,000 a year:

"And whereas Your Majesty was graciously pleased by Your Order in Council bearing date the 29th day of June, 1934, to authorise, *inter alia*, payment of the said salary at the current rate of £900 a year:

"And whereas we are of opinion in consideration of the increased responsibilities attached to the post that this remuneration should be improved:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction a scale of salary for the post of Chief Constable, Royal Marine Police, of £900 a year rising by annual increments of £45 a year to £1,080 a year, such scale being substituted for the current rate of £900 a year authorised by Your Majesty's Order in Council dated the 29th day of June, 1934.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 10th day of September, 1934 (C.W. 6608/34), in the words following, viz. :—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas Your Majesty was graciously pleased by Your Order in Council bearing date the 2nd day of August, 1918, to sanction the grant, at our discretion, of Temporary

Commissions as Acting Chaplains to Ministers of Religious Bodies, not in conformity with the Church of England, who rendered full time service in the Royal Navy during the period of the late war:

"And whereas Your Majesty was graciously pleased by Your Order in Council bearing date the 13th day of October, 1922, to sanction the continuance of the grant of Temporary Commissions to such Ministers under the same conditions in time of peace, subject to their being designated 'Temporary Chaplains' and not 'Acting Chaplains':

"And whereas the Reverend William Williams was granted a Temporary Commission as Acting Methodist Chaplain (now styled 'Temporary Methodist Chaplain') with seniority of the 2nd August, 1918, (subsequently adjusted to the 26th October, 1915, in respect of previous service) and served in Your Majesty's Naval Service until the 31st August, 1934, on which date he was placed on the retired list at his own request:

"And whereas we consider that such service should render this Officer eligible for retired pay:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the following proposals:—

(1) Retired pay based on a standard rate of £315 a year to be granted to this Officer and to be awarded at the current rate of £283 10s. a year as from the date of his retirement;

(2) The standard rate of £315 a year to be regarded as comparable with rates authorised in Schedule V, Section IX, of Your Majesty's Order in Council bearing date the 22nd January, 1920, and his retired pay to be subject to revision as may from time to time be prescribed for rates authorised by that Order.

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval
