The KING has been graciously pleased to approve of the Award of the Medal of the Civil Division of the Most Excellent Order of the British Empire to the undermentioned:—

#### For Gallantry.

Edward Omara, a native of the Chua District, Northern Province, Uganda, for conspicuous gallantry displayed on two occasions.

A Game Scout, who was anxious to punish a herd of marauding elephants had wounded two bulls when one of them charged him and pinned him to the ground. Omara pulled out the Scout's rifle from between the elephant's feet and being unable to reload he attacked the elephant with his spear. He drove it off and eventually killed it and then carried the Scout, whose injuries unfortunately proved fatal, for three hours to Adilang. In February last an elephant which had been burnt in a bush fire and was consequently in a most dangerous temper took possession of a village waterhole and terrorised the local population. Omara at very great risk to himself and in the interests of his fellow-villagers killed it with a heavy hunting spear.
