#### URBAN DISTRICT OF WIRRAL.

PUBLIC HEALTH ACTS AMENDMENT ACT, 1907,  
AND PUBLIC HEALTH ACT, 1925.

**B**y an Order dated the 25th day of September, 1934, the Minister of Health has declared that, on and after the 19th day of November, 1934, the following provisions of the above-mentioned Acts shall be in force in the Urban District of Wirral, namely:—

The Public Health Acts Amendment Act, 1907:—

Part II. (streets and buildings) other than sections 21, 24, 25, 30 and 31;

Part III. (sanitary provisions) other than section 51;

Part IV. (infectious diseases) other than sections 61, 66, 67 and 68;

Part V. (common lodging-houses);

Part VI. (recreation grounds); and

Sections 92 and 94 comprised in Part X. (miscellaneous provisions).

The Public Health Act, 1925:—

Part VI. (recreation grounds):

The above provisions are declared to be in force subject, as regards Sections 23, 27, 35, 38, 75 and 92 of the Act of 1907 to the conditions specified in the Order.

WATER SUPPLIES (EXCEPTIONAL SHORTAGE  
ORDERS) ACT, 1934.

**N**OTICE is hereby given that the Burton Latimer Urban District Council have made an application to the Minister of Health for an Order under the provisions of Section 1 &c. of the Water Supplies (Exceptional Shortage Orders) Act, 1934, relating to approximately half-an-acre of land immediately adjoining Double Dug Spinney in the Parish of Burton Latimer in the County aforesaid, on the north, west, and south sides of the Spinney, which Spinney is marked "Double Dug Spinney" No. 82 on the Ordnance Survey Map of Northamptonshire, Sheet XXXII-7, 1926 Edition.

Such application to the Minister of Health as aforesaid comprises a request for an Order under the above Act authorising:—

(1) The right of entry by the Council upon the land specified above on seven days notice to the Owner and Occupier (Sec. 2 (b)).

(2) The taking by the Council of water from the land specified above for an indefinite period, and

(3) The purchase by the Council either compulsorily or by agreement of the land specified above (Sec. 3 (1)).

Representations with regard to this application may be made to the Minister of Health within seven days from the date of publication of this Notice.

#### BRIDPORT WATER WORKS COMPANY.

WATER SUPPLIES (EXCEPTIONAL SHORTAGE  
ORDERS) ACT, 1934.

**W**HEREAS the Minister of Health made an Order on the 22nd day of June, 1934, to continue in force for a period of six months from that date and to authorise the Bridport Water Works Company to take water from the stream passing through the grounds of the Rectory at Litton Cheney in the County of Dorset to an amount not exceeding fifty thousand gallons per day and for that purpose to enter upon the lands after giving the requisite notice to the owner and occupier and to make such excavations erect such machinery lay such pipes and carry out such other works as may be necessary for the purposes authorised by the Order.

Notice is hereby given that we, the undersigned, on behalf of the Bridport Water Works Company aforesaid, have made an application to the Minister of Health for the issue of a further Order to empower the said Company to take for an indefinite period a quantity of water not exceeding two hundred thousand gallons per day from the stream aforesaid and for this purpose to make excavations erect machinery and lay down pipes and do such other works in connection therewith as may be necessary in the grounds aforesaid and in certain lands situate at Litton Cheney aforesaid belonging to Harry Benjamin
