#### SCHEDULE.

Subject to the exceptions set out in Paragraph V, no person shall drive or cause to be driven on the roads specified in the First Schedule hereto any heavy locomotive, light locomotive, motor tractor or heavy motor car (as respectively defined in Section 2 of the Road Traffic Act, 1930, or in any Regulations made or to be made thereunder) or any motor car (as defined as aforesaid) with seats for more than fourteen persons exclusive of the driver.

II. No person shall drive or cause to be driven any vehicle on any road specified in the first column of the Second Schedule hereto otherwise than in the direction specified in the second column of that Schedule.
