

excess, effect shall be given to any relevant adjustments under Clauses 48 and 49."

18. Clause 86 of the Scheme shall have effect as if the following paragraphs were inserted at the end thereof, that is to say:—

"And provided further than no owner shall be entitled to refer any matter to arbitration unless he shall have given notice in writing to the Board of his intention to do so within 28 days after notice of the matter complained of shall have been given to him by the Board or (in the absence of any such notice as last aforesaid) within 28 days after he first became aware of such matter. For the purposes of this proviso in any case in which an owner being entitled so to do under any of the provisions of the Scheme applies to the Board for reconsideration of any decision the aforesaid period of 28 days shall be computed from the date on which notice is given to him of the decision of the Board on such reconsideration:

Provided further than an arbitrator may extend the time for giving notice under this Clause if the delay in giving notice has been due to accident or mistake and the Board have not in the meantime relied on the absence of notice and altered their position so as to be prejudicially affected by an arbitration."
