(2) That when the above-mentioned examination is held concurrently with the examination for appointments in the Indian Police Service or the examination in connection with the selection of Police Probationers for service in Ceylon, the fee payable by candidates admitted simultaneously to two or more of those examinations in London shall be a consolidated fee of £4.

HARROGATE.

Whereas the Mayor, Aldermen and Burgesses of the Borough of Harrogate (hereinafter called the Corporation) have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Harrogate Waterworks Act, 1897, the Harrogate Corporation (Waterworks Transfer) Act, 1897, the Harrogate Water Act, 1901, the Harrogate Water Act, 1903, the Harrogate Corporation Water Act, 1911, and the Harrogate Corporation Act, 1924, so as:

- (1) To extend the limits within which the Corporation may supply water so as to include within those limits the parishes of Brearton, Farnham, Felliscliffe, Ferrensby, Flaxby, Follifoot, Goldsborough, Hamps-Plompton, Killinghall, thwaite, Nidd, Ripley, Scotton, South Stainby-with-Cayton, and Walkingham Hill-with-Occaney in the Rural District of Knaresborough, and to provide that the rates and charges for the supply of water for domestic purposes in such parishes shall be the same as those in force within the borough:
- (2) To provide for the cesser of the rights and obligations of the Knaresborough Rural District Council relating to the supply of water in the said parishes:
- (3) To empower the Corporation to purchase the mains works lands and buildings of the Knaresborough Rural District Council contained in the said parishes, except those at Saltergate Hill, and to transfer to the Corporation the obligations of the said Council in respect thereof:
- (4) To make further provision with regard to the supply of water by the Corporation and, in particular :-
 - (a) To empower the Knaresborough Rural District Council to give guarantees to the Corporation for securing payments in respect of the laying down of water mains in the rural district.
- (b) To limit the pressure at which the Corporation shall be required to supply water within the added limits.
- (c) To extend the powers of the Corporation to make byelaws for preventing waste of water.
- (d) To empower the Corporation to require cisterns to be provided for high level supplies.
