RURAL DISTRICT OF WELTON.

THE PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

BY an Order dated the 4th day of March, 1935, the Minister of Health has declared that on and after the 18th day of March, 1935, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the several contributory places within the Rural District of Welton, namely, Section 23 (which relates to new buildings) comprised in Part II of the said Act subject, however, to the provisions of Section 33 (which relates to the exemption of certain buildings) and subject to the conditions hereinafter referred to.

The above provisions are declared to be in force subject to the conditions specified in the Order.

A copy of the Order may be inspected at 25, Clasketgate, Lincoln, between the hours of 10 o'clock in the forenoon and 4 o'clock in the afternoon on any week-day except Saturdays when the hours will be from 10 o'clock in the forenoon to 12 noon.

(Application for Special Order under the Gas Undertakings Acts 1920 to 1934).

NOTICE is hereby given that application is intended to be made to the Board of Trade by the Wandsworth and District Gas Company (hereinafter called "the Company") whose address is at Fairfield Street, Wandsworth, London, S.W.18, for a Special Order under the Gas Undertakings Acts 1920 to 1934 for all or some of the following purposes (that is to say):—

To provide for the transfer to and vesting in the Company of the undertaking of the Leatherhead Gas and Lighting Company (hereinafter referred to as "the Leatherhead Company") including all rights of making distributing and supplying gas and all other the rights, easements, powers, authorities and privileges whatsoever of the Leatherhead Company and all property whatsoever including cash balances, reserve and other funds (if any), investments, interests, obligations and things in action belonging to the Leatherhead Company but subject to all contracts, debts, liabilities, obligations and incumbrances of the Leatherhead Company.

To provide for the amalgamation of the undertaking of the Leatherhead Company with the undertaking of the Company and for the dissolution of the Leatherhead Company.

To provide for the increase of the capital of the Company by the amount of the stock of the Company to be issued to holders of Ordinary Shares and Preference Stock of the Leatherhead Company.

To provide for the issue to the holders of Ordinary Shares or Preference Stock or De-
