DANGEROUS DRUGS ACTS, 1920-1932.

WITHDRAWAL OF AUTHORITY.

Whereas John Alex. Ross, M.B., Ch.B. (Aberdeen), of 18, Blake Road, Fulham, London, S.W.6, has been convicted of offences against the Dangerous Drugs Acts:

And whereas the said John Alex. Ross cannot, in my opinion, properly be allowed to be in possession of or to supply any of the drugs or preparations to which Part III of the Dangerous Drugs Act, 1920, applies:

Now, therefore, in pursuance of the powers conferred on me by Regulation 6 of the Raw Opium Regulations, 1921, as extended by the Coca Leaves and Indian Hemp Regulations 1928, and by Regulation 7 of the Dangerous Drugs (Consolidation) Regulations, 1928, I hereby give notice that I withdraw, as from to-day's date, from the said John Alex. Ross, the authority granted by the said Regulations to duly qualified medical practitioners to be in possession of and to supply raw opium, coca leaves, Indian hemp, and the drugs and preparations to which Part III of the Dangerous Drugs Act, 1920, applies:

And I also direct, as from the same date, that it shall not be lawful for the said John Alex. Ross to give prescriptions for the purposes of the Dangerous Drugs (Consolidation) Regulations, 1928.

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day-shifts, of women of 18 and young persons of 16 years of age and over in preparing for dyeing, examining, folding, rolling after dyeing and finishing in the Silk Warehouse at the Levenbank Works of The United Turkey Red Co. Ltd., Jamestown, Dumbartonshire, subject to the conditions that

a worker shall not be employed in the afternoon shift in consecutive weeks and that suitable accommodation for clothing put off during working hours, messroom accommodation and washing facilities shall be provided; and that the Secretary of State may at any time require the occupiers to make such special arrangements for the conveyance of workers living at a distance or otherwise for the welfare of such workers as may be necessary to prevent hardship.
