and upon the north by an imaginary line commencing at the point where the boundary which divides the said New Parish of Saint Michael and All Angels, Bedford Park, from the said New Parish of Saint Alban the Martyr, Acton Green, crosses the fence forming the southern boundary of the said house and premises known as Number 53, Esmond Road, and extending thence westward along such fence and along the fence forming the southern boundary of the house and premises known as Number 54, Ramillies Road, for a distance of 2 chains or thereabouts to the point where the last mentioned fence reaches the eastern side of Ramillies Road, and extending thence westward in a straight line across Ramillies Road for a distance of 16 yards or thereabouts to a point in the middle of the eastern end of the passage leading past the southern side of the house and premises known as Number 1, Ramillies Road, into Rusthall Avenue, and extending thence north-westward along the middle of such passage for a distance of $1 \frac{3}{4}$ chains or thereabouts to the point where it reaches the eastern side of Rusthall Avenue, and extending thence first westward to and then northward along the middle of Rusthall Avenue for a distance of $7 \frac{1}{2}$ chains or thereabouts to a point opposite to the western end of the fence forming the southern boundary of the house and premises known as Number 94, Rusthall Avenue, and extending thence eastward to and along such fence for a distance of 3 chains or thereabouts to the boundary which divides the said New Parish of Saint Alban the Martyr, Acton Green, from the said New Parish of Saint Michael and All Angels, Bedford Park."

And whereas drafts of the said Scheme or Representation have been transmitted to the Patron and to the Incumbents of the Cures affected by the arrangements which are contemplated by such Scheme or Representation and such Patroh and Incumbents have respectively signified their assent thereto:

And whereas the said Scheme or Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part theffeof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.
And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of London.

## PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and
of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Ohapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 11th day of April, 1935, in the words and figures following, that is to say:-
"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called ' the said Benefice') of Bidford, in the County of Warwick and in the Diocese of Coventry:
".Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Bidford is vested for an estate in fee simple without incumbrances in the Right Reverend Mervyn, Bishop of Coventry, in his private capacity:
" And whereas the said Mervyn, Bishop of Coventry, is desirous that the whole Advowson or perpetual right of Patronage of or presentation to the said Benefice of Bidford now vested in him as aforesaid, should be transferred to and be vested in the Bishop for the time being of the said Diocese of Coventry :
"And whereas the said Mervyn, Bishop of Coventry, has executed this Scheme as hereinafter mentioned in token of such his desire and of his willingness as such Bishop to accept such transfer and also in token that the same transfer has that consent of the Bishop of the Diocese which by the hereinbefore mentioned Acts or by some or one of them is made necessary:
" And whereas the transfer of the Patronage of the said Benefice of Bidford which is hereinbefore mentioned and hereinafter recommended and proposed will render the same Benefice more eligible for augmentation out of the funds under our control, and this circumstance will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Bidford:
"Now, therefore, with the consent of the said Mervyn, Bishop of Coventry (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice
